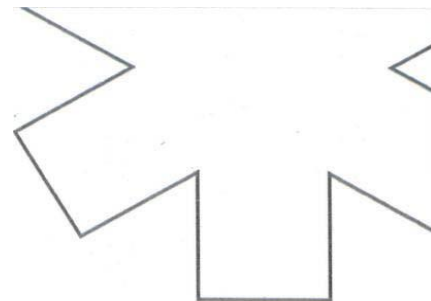

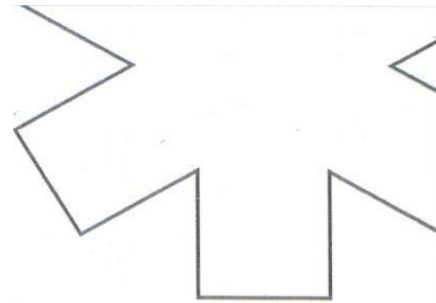

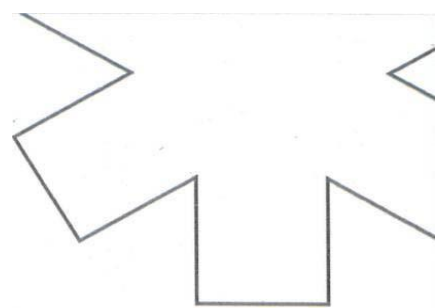

**1. TERMS OF PAYMENT**

**2. INTEREST**

**4. PERSONAL RESPONSIBILITY**

Where the client is a corporation or a separate legal entity from the actual signatory, such signatory is jointly and severally liable towards Enviro Urgence to comply with any obligation arising from purchases made, following this account opening application, under these terms, as if the signatory would be personally responsible. Moreover, the signatory waives any benefit of division, discussion, and subrogation.

**5. DOMICILE ELECTION**

For the purposes of this agreement, the parties' elect domicile in the judicial district of Terrebonne (Quebec).

**6. PENALTY CLAUSE**

In cases where Enviro Urgence must undertake legal procedures to recover unpaid sums of money, the customer agrees to pay Enviro Urgence all costs of recovery as well as the principal and interest.

**7. DURATION**

The present agreement is valid for an indefinite period. Enviro Urgence may terminate such agreement, at its own discretion, by sending, seven (7) days prior notice to the client or may cancel it immediately if the client has failed to comply with one of the conditions stated above.
